THE ORGANIZATION OPERATES TWO RONALD MCDONALD HOUSES AND ONE RONALD MCDONALD FAMILY ROOM IN A HOSPITAL. RONALD MCDONALD HOUSES PROVIDE TEMPORARY, AFFORDABLE, AND SAFE LODGING FOR OUT-OF-TOWN FAMILIES OF CHILDREN WHOSE MEDICAL NEEDS CAUSE THEM TO COME TO WICHITA, KS. THE FAMILY ROOM PROVIDES A LOCATION INSIDE THE HOSPITAL FOR TEMPORARY RESPITE FOR FAMILIES WHOSE CHILDREN ARE ADMITTED TO THE HOSPITAL. OVER 28,500 FAMILIES HAVE USED THE HOUSES SINCE ONE OPENED IN 1983 AND THE OTHER IN 1985. DURING 2018, THE HOUSES SERVED 638 FAMILIES. THEY COME FROM 105 KANSAS COUNTIES, 45 OTHER STATES, AND 14 COUNTRIES. OVER 26,625 FAMILIES FROM KANSAS AND OTHER STATES HAVE FOUND RESPITE IN THE FAMILY ROOM SINCE ITS OPENING IN 1998. DURING 2018, APPROXIMATELY 806 FAMILIES USED THE FAMILY ROOM.
